



### **She Loves Tech India 2020 - The National Grand Challenge**

### **Guidelines**

### **Introduction**

Kerala Startup Mission is organising a Virtual Startup Competition, partnering with She Loves

Tech - focusing on developing a network for entrepreneurs, companies, and investors to promote technology for women and women technopreneurs in India. This is a tech startup competition that focuses on businesses led by women on one hand and startups dedicated to improving the lives of women globally, on the other.

### **Format**

The National Grand Challenge (preliminary round) will be held virtually on 31st October 2020, with the winner entering virtually for the Global finals.

**Registration** - The registration time period for startups will be from 9th September 2020 – 3rd October 2020. The Startup applications will undergo a screening process and 20 startups will be shortlisted for mentoring and 10 startups (among the selected 20) will pitch for The National Grand Challenge of She Loves Tech India 2020

**26th October 2020 – Mentorship Round** – This round mainly focuses on helping the startups polish their pitch decks and prepare for their pitches. The registered startups will undergo a screening process and 20 startups will be shortlisted for the mentorship round organized by Kerala Startup Mission.

**28th October 2020 - Investor Café -** Investor café is KSUM-branded monthly funding opportunity for startups looking for funds to connect with investors and get funded through Kerala Startup Mission. The shortlisted 20 startups for the mentoring round can get funded from 10 investors and have one-to-one interactive sessions with them.

**31st October 2020 - She Loves Tech India 2020 The National Grand Challenge -** From the shortlisted 20 startups, the best 10 startups will get an opportunity to pitch in the National Grand Challenge. The National Grant Challenge winner (One startup) will have the opportunity to pitch for the Global Event virtually and can attend Boot camp and will have access to the International Conference. The Startup will have 5 minutes to pitch on stage and 3 minutes for Q&A.

**November 2020 – Virtual Bootcamp and She Loves Tech Global Finals 2020 –** The global finals of the She Loves Tech 2020 Global Startup Competition will be held during the She Loves Tech 2020 International Conference happening on November 2020 virtually. Each finalist will have 5 minutes to pitch on stage and 3 minutes for Q&A.

# How to apply for She Loves Tech 2020 Global Startup Competition

To be eligible for the competition, startups must meet the following requirements:

#### **Stage**

Startups seeking seed, angel or Series A round funding (under US\$5M) with at least a minimum viable product (past conceptual stage).

#### **Focus**

- i. Any entrepreneur male or female who is using technology to impact women positively: a. Are a significant proportion of end-users or consumers female?
- b. Are products specifically designed with women users in mind?
- c. Does the product itself address a problem that disproportionately affects women?

ii. At least one female entrepreneur in founding team who is using technology to solve a problem

#### **Technology**

The use of science and innovation to invent useful things or to solve problems. This extends beyond digital, information or internet-based technology and covers everything from hardware to the creation of new products and solutions to existing problems.

To be part of the She Loves Tech 2020 Global Startup Competition, eligible applicants must submit all registrations online, in compliance with the competition's guidelines and according to the instructions set forth in the website. Participation in the She Loves Tech India 2020 Global Startup Competition constitutes the applicant/team's full and unconditional agreement to these guidelines and decisions of the organiser, which are final and binding in all matters related to the She Loves Tech India 2020 Global Startup Competition.

The She Loves Tech team along with a panel of industry experts will review all submitted entries and shortlist candidates who will be invited to pitch at the National Grand Challenge. We are looking at a range of criteria including market opportunity, traction, scalability and growth potential, innovation and creativity, calibre of founder and team, and last but not least, women impact.

# **Declaration Agreement**

In registration for the She Loves Tech 2020 Global Startup Competition, each applicant agrees to:

· Ensure all submitted projects are the original work of the applicant/team and all information are true and accurate at penalty of immediate disqualification;

- · Attend the event if selected, make a public presentation of their business plan at the National Grand Challenge, Cochin, Kerala and the global round, and participate in other organized events in relation to the overall program; and
- · Follow all of the She Loves Tech 2020 Global Startup Competition guidelines and instructions of the Organiser, and accept the Organiser's decision
